- Entry once submitted cannot be withdrawn;
- One participant can submit only one entry. Multiple entries from the same entrant will not be considered and will be discarded;
- The EKWMA will not be responsible for loss of entry during transit through post or e-mail. Please note proof of submission of the entry is not proof of receipt of the same;
- If a winner is not contractable within one week from the date of announcement of result the prize will be forfeited and another winner will be selected from the remaining eligible entries in accordance with the above process;
