### **Introduction: East Kolkata Wetlands**

The residents of Kolkata are fortunate to have inherited a 12,500 ha of wetland complex (a mosaic of water bodies, agricultural, horticultural and habitation area) called East Kolkata Wetlands (EKW), situated to the east of the city. EKW is the world's largest sewage-fed pisciculture system. This kind of pisciculture practice provides survival opportunities for a large, economically underprivileged community living in this wetlands area. A traditional waste recovery system of this wetlands area saves the State exchequer from a huge capital expenditure. This wetlands complex is unique as these features are unlike to any other Wetlands / Ramsar sites in India.

The EKW saves Kolkata from inundation during heavy rains and storms as it provides a basin

where the city's excess rainwater naturally drains out.Sixty percent of carbon found in the wastewater is sequestered by the plant and animal life of the wetlands. Considering the ecological and social significance, the UNESCO designated international importance to



this wetlands area by adding it to the Ramsar list in 2002.

This wetlands complex has 48% of its area under water (including 260 fish firms), 27% under agriculture, 20% under habitation, 2% under horticulture and canals and 1% under landfills, out of the total 12500 ha. This wetlands area produces more than 20,000 tons of fish and more than 50,000 tons of vegetables per annum.

## **Composition and Functions of East Kolkata Wetlands Management Authority**

In order to conserve and manage this unique wetlands complex the State Government framed a specific act namely East Kolkata Wetlands (Conservation and Management) Act, 2006 [EKW(C&M) Act, 2006]. East Kolkata Wetlands Management Authority (EKWMA), a statutory body, was formed under the Department of Environment, Government of West Bengal under Section 3 of the said Act for proper conservation and management of the EKW area. After formation of the Wetlands (Conservation and Management) Rules, 2010 under the Environment (Protection) Act, 1986 by the Ministry of Environment, Forest and Climate Change (MoEF&CC), EKW being a Ramsar Site came under the purview of this Rules as a wetland of international importance under the Ramsar Convention. The Wetlands (Conservation and Management) Rules, 2010 was superseded by the Wetlands (Conservation and Management) Rules, 2017 [Wetlands (C&M) Rules, 2017].

#### 2.1 Composition of the EKWMA

In the year 2017, EKWMA was reconstituted with thirteen members' body including four expert members in the field of hydrology, fisheries, ecology and socio-economics by amendment of the sub-section 2 of the section 3 of EKW (C&M) Act, 2006.

It was decided in the 28<sup>th</sup> meeting of the EKWMA that the Commissioner, Kolkata Municipal Corporation, District Magistrates of South 24 Parganas and North 24 Parganas would be permanent Invitee Members of the Authority. Four expert members from the field of wetland ecology, hydrology, fisheries, and socio-economics have been nominated for a period of three years by the State Government on 18.08.2020.Member list is given at Table 1.

#### 2.4 Functions and Powers of the EKWMA

The EKWMA has following functions as per the EKW (C&M) Act, 2006.

- To demarcate the boundaries of the East Kolkata Wetlands.
- To take measures or make an order to stop, undo and prevent any unauthorised development project in, or unauthorised use of, or unauthorised act on, the East Kolkata Wetlands.
- To make an order directing demolition or alteration of any hoarding, frame, post, structure, etc. erected or exhibited illegally within the EKW.
- To take measures to abate pollution in the East Kolkata Wetlands and conserve its flora, fauna and biodiversity in general.
- To prepare action plans conforming to the resolutions taken and recommendations made, from time to time, under the Ramsar Convention and to update the land use maps of the East Kolkata Wetlands.
- To implement and monitor the activities specified in the action plans
- To promote research and disseminate findings of such research among the stakeholders.
- To raise awareness about the utility of the wetlands in general and the East Kolkata Wetlands in particular.
- To promote basic conservation principles like sewage fed pisciculture and eco-tourism in the East Kolkata Wetlands.
- To enforce land use control in the substantially water body oriented areas and other areas in the East Kolkata Wetlands.
- To detect changes of ecological character and in land use in the East Kolkata Wetlands.
- To establish network with other Ramsar Sites in India.

#### 2.5 Meetings of the EKWMA

During the year 2022-23, 30<sup>th</sup> meeting of EKWMA was held on 03.06.2022 at the Chief Secretary's conference hall on 13<sup>th</sup> Floor, Nabanna. The meeting was chaired by Shri Hari Krishna Dwivedi, Chief Secretary, Government of West Bengal. A copy of the minutes of the meeting is attached in Annexure-I.

# Major Activities of East Kolkata Wetlands Management Authority during the year 2022-23

# **3.1.** Enforcement of East Kolkata Wetlands (Conservation and Management) Act, 2006 against illegal encroachments within East Kolkata Wetlands area.

Since East Kolkata Wetlands area is in the outskirts of Kolkata, it faces several anthropogenic threats from the developers and land sharks for attempting to make rampant encroachments and illegal constructions within this wetlands area. The area of this wetlands complex overlaps with the two Municipal areas, Kolkata Municipal Corporation (KMC) and Bidhannagar Municipal Corporation (BMC). In order to protect and conserve this unique wetlands of international importance, the East Kolkata Wetlands Management Authority has not only been playing the pivotal role of a watchman, but also providing healing touch to the damage of the unique ecosystem of this wetlands area caused by the encroachers. EKWMA undertakes various steps as per the provisions of East Kolkata Wetlands (Conservation &

Management) Act, 2006 to protect and conserve the vast sketch of 12,500 ha of this wetland area which are detailed below.

3.1.1. Implementation of Section 11 of the East Kolkata Wetlands (Conservation and Management) Act, 2006

EKW, regular monitoring is undertaken by the staff of the EKWMA with assistance of the

concerned police authorities. Upon finding any illegal activity during regular inspection in the EKW area or upon receiving any complaint against violation of Section 9 of the East Kolkata Wetlands (Conservation & Management) Act of 2006 and Rule 4 (2) of the Wetlands (Conservation

&Management) Rules of 2017, **EKWMA** issues order to immediately stop illegal activity and the restore the land to its original status within а stipulated period of time at the expense of the violator, after providing him with a hearing opportunity for the sake of the principles of



natural justice and as per the provision of Section 11 of the EKW (C&M) Act, 2006. In case, any law suit is filed on being directed by the judiciary the EKWMA provides the same hearing opportunity to the violators / petitioners. # 3.1.2 Implementation of Section 18 of the East Kolkata Wetlands (Conservation and Management) Act, 2006

In case of failure to act on any order issued by EKWMA or contravenes any provisions of the EKW (C&M) Act of 2006, EKWMA lodges complaint with the local police station to take action in accordance with Section 18 of the EKW(C&M) Act, 2006.Up to March 2023, 487 complaints with various police stations have been lodged by the EKWMA against the violations of the afore-said law; while during this financial year 42 complaints have been lodged.

# **3.1.3. Demolition of Unauthorized Constructions and Restoration of Water Body**

As per the provision of Section 11 of EKW(C&M) Act, 2006 or as per direction of the Hon'ble Courts, EKWMA issues order against the violators with the direction to demolish the illegal construction and restore the land to its previous condition at his own cost. Failing which, EKWMA undertakes the demolition / restoration work it-self and recovers the cost thereof as arrears of land-revenue. During this financial year, following demolition and restoration works have been carried out within the EKW area:

i) After getting information about illegal construction of concrete wall for the purpose of making bridge over a canal namely Ghosher Khal at Mouza- Dhapamanpur by obstructing natural sewage flow of the canal, EKWMA lodged complaint with South Bidhannagar Police Station. On 11.03.2022, the Hon'ble National Green Tribunal in the matter of O.A. No.

78/2016/EZ directed Bidhannagar Municipal Corporation (BMC) to demolish illegal concrete wall at Ghosher Khal. Accordingly, BMC has demolished the above said construction on April, 2022.

ii) EKWMA noticed that unauthorized two boundary walls including a plastic recycle unit had been constructed at part of RS Dag no. 1147, Mouza Dhapa, JL no. 2, under PS Anandapur, KMC Ward No. 108. Accordingly, EKWMA pasted a notice alleged on the walls directing to stop work and



restoring the subject land to its original character. Failing the afore-mentioned order, EKWMA lodged complaint with Anandapur Police Station against unauthorized construction of boundary walls and requested the KMC to demolish the above said boundary walls. The work for demolition was done in July, 2022 in presence of the EKWMA and the KMC officials.

iii) On noticing that an unauthorized three storey building has been constructed by filling up of water bodies namely Baro Bongheri, Choto Bongheri and Robi Ghosher Bheri at Mouza Dhapamanpur under North 24 Parganas District, EKWMA served a notice with a direction to stop work immediately and lodged complaint with South Bidhannagar Police Station. As per Section 11 of the EKW(C&M) Act, 2006 and direction of the Hon'ble High Court at Calcutta in the matter of WPO no. 541/2017, EKWMA issued an order with a direction upon the violators to demolish the three storey building within one month. Due to non-compliance with this direction, EKWMA requested District Magistrate, North 24 Parganas to demolish the three storey building. The demolition work was done in March, 2022. After that, EKWMA requested Bidhannagar Municipal Corporation to restore the said water bodies. A

fund of Rs. 1,99,94,738/was released by Environment Department directly in favour of the BMC for the restoration work. The work of restoration of the water bodies was completed in November, 2022.

# **3.2. Reply to Right** to Information Act



The basic objective of the Right to Information Act, 2005 (RTI) is to empower the citizens, promote transparency and accountability in the working of the Government and make the democracy work for the people in real sense. It mandates timely response to public queries for Government information. Being a 'Public Authority', the EKWMA is under obligation to furnish information sought for in various RTI applications that are received. During the year 2022-2023, 48 applications have been received and subsequently replied to the people.

#### 3.3. Status of Court Cases

Several civil suits are filed before the Hon'ble Calcutta High Court and the Hon'ble National Green Tribunal (NGT), Eastern Zone Bench, Kolkata against violations that have occurred under the EKW(C&M)Act, 2006 and the Wetlands (C&M) Rules, 2017 as well as challenging the provisions of said Act and Rules. Upto March, 2022, cases filed before the NGT are disposed of and 35 cases filed before the Hon'ble High Court at Calcutta are pending. The list of pending cases before the Hon'ble High Court at Calcutta is annexed in Annexure-VIII.

#### 3.4. Initiation of Solid Waste Management Project within East Kolkata Wetlands

Solid Waste Management Project at Kheadaha II Gram Panchayat and Bamanghata Gram Panchayat was finalized after getting administrative and financial approval from Department of Environment. This project is in convergence mode with Panchayat and Rural



Development Department. Two Civil Society Organisations namely, Amra Susama Jalprapat and BITAN Institute of Training Awareness and Networking were engaged as anchor for sensitizing the local community to run this project. The work of Solid Waste Management Project is presently ongoing.

#### 3.5. Demarcation of Boundary of East Kolkata Wetlands

It is mentioned in Section 4(1) (a) of East Kolkata Wetlands (Conservation and Management)

2006 Act, that the boundary of East Kolkata Wetlands (EKW) is to be demarcated. To comply with this, ground truthing was done in co-operation with DL&LRO of North and South 24 Parganas in whole EKW the area except the area under ATM Kasba block. After



finalization of the waypoints, it was decided that physical demarcation would be done by erecting pillars at a certain interval in the same manner as is done for demarcating forest boundary.

Furthermore, the Hon'ble National Green Tribunal (NGT) in the matter of O.A. 32/2019 directed that the boundary of the East Kolkata Wetlands area has to be demarcated by erection of pillars. In compliance with the direction and Section 4(1) (a) of EKW(C&M) Act, 2006, EKWMA started erection of monolith pillars for demarcation the EKW boundary with the help of North and South 24-Parganas District Administrations. Till date 1048 monolith pillars have been erected along the boundary of the EKW.

# **3.6. Implementation of Integrated Management Plan (IMP) of East Kolkata Wetlands 2021-2026**

East Kolkata Wetlands Management Authority was created to maintain ecological character of East Kolkata Wetlands and in doing so, retaining those essential ecological and hydrological functions which ultimately enable the wetland to provide its provisioning, regulating and cultural services. Having a system to describe, monitor and detect changes in ecological character is, therefore, critical to support decision making for wise use of this Ramsar Site. It is equally important to assess effectiveness of management in terms of ability to develop and implement an integrated planning, management and evaluation system to secure wise use of the wetland. To reach this purpose, an Integrated Management Plan of East Kolkata Wetlands (Management Action Plan 2021-2026) had been prepared as per the guidelines of National Plan for Conservation of Aquatic-ecosystem (NPCA). The current version of the IMP describes a monitoring framework for the EKW to support integrated management and wise use of this wetland. The IMP was approved by the Government of West Bengal and by the Ministry of Environment, Forest and Climate Change (MoEF&CC) with the sanction of Rs. 66.359 Crore. This is a Centrally Sponsored Scheme with the Central Government share of 60% and the State Government share of 40%. The budget allocation for the 1st year is Rs. 9.995 Crore. Both the Central and the State Governments have released 25% of their respective shares for the 1st year. Execution of work for the 1st year has started, which is briefly described below.

#### i. Stake holders' Workshop:

East Kolkata Wetlands Management Authority organized a Stakeholders' Workshop to understand the challenges faced by local community of EKW and to discuss the work plan of the IMP of EKW by



engaging local community. The workshop held on 13.01.2023 at Biswa Bangla Milan Mela Prangan, Kolkata. Brief of the workshop is described in Chapter 4.2.

#### ii. Celebration of World Wetlands Day:



On 2<sup>nd</sup> February, 2023 EKWMA celebrated World Wetlands Day at Bantala lockgate. The programme is elaborated in Chapter 4.1.

iii. Studies on Bioaccumulation of Heavy Metal in fishes and vegetables grown within East Kolkata Wetlands :

Institute of Environmental Studies and Wetland Management (IESWM) has earlier conducted studies on contamination of heavy metals in vegetables and fishes in different District of the

State. Accordingly, EKWMA has engaged IESWM to conduct a study on contamination of heavy metals in vegetables and fishes grown in EKW area.

#### iv. Canal De-siltation Programme:

The water bodies (called bheries) of this wetland complex area are connected to several major and minor canals which carry sewage water to the bheries. For this reason, canals of EKW



get silted very fast which affects the production of fishes as well as livelihood of local community. To overcome this problem, Water Resources Investigation and Development Department (WRI&DD) was approached for de-siltation of fourteen canals in the EKW area to maintain optimum water

level in the bheries. The work for de-siltation of canals is under process.

#### v. Excavation / De-siltation of bheries within East Kolkata Wetlands

Pisciculture in EKW sustains on regular supply of sewage water. Due to this reason, sewage water supply is essential for the bheries which however get silted very fast. To resolve this issue, de-siltation of bheries within EKW area is necessary. In this regard, State Fisheries Development Corporation submitted a proposal for de-siltation of four ponds under their control, which are situated at Nalban Bheri area. EKWMA agreed with this proposal and decided to provide financial support.

Besides that, EKWMA has attempted to start the works on Asian Water Bird Census, Erection of signages, Establishment of Nature Interpretation Centre, Assessment of production of fishes and vegetables and its diseases, eradication of invasive fish species, promotion of indigenous fishes, etc.

### **Awareness Generation Programmes**

East Kolkata Wetlands is situated just adjacent to the metropolitan city Kolkata. Due to the huge pressure of urbanization, the EKW is under tremendous stress of encroachment. The human settlement pressure affects not only the water bodies of the EKW, but also its unique biodiversity. Most of the time, common people encroache the land in EKW due to lack of information about the importance of EKW as well as about the activities prohibited under East Kolkata Wetlands (Conservation &Management) Act, 2006 and Wetlands (Conservation &Management) Act, 2006 and Wetlands (Conservation &Management) Act, and Rules, East Kolkata Wetlands Management Authority has power to take measures to generate awareness within the stakeholders and local community on values and functions of wetlands. Following steps have been carried out in this regard:

#### 4.1 Celebration of World Wetlands Day

In the year 2023, the for World theme the Wetlands Day was "wetland restoration". In light of this, EKWMA celebrated the World Wetlands Day along with People United for Better Living in Calcutta (PUBLIC, an NGO). The students of La Martiniere for Girls school and



National Institute of Juridical Sciences (NUJS), West Bengal took part in this occasion. The programme was organized at Bantala lockgate area of East Kolkata Wetlands (EKW).

During the occasion, the students were apprised of the importance of the unique ecosystem of EKW. The students were informed that there are several endangered faunal and floral species in this wetlands area.

At the end of the event, the students were taken for a walk along the bheries of Bantala area. The students interacted with the local fishermen and came to know about the traditional pisciculture system.

#### 4.2. Stakeholders' Workshop on East Kolkata Wetlands



Kolkata Wetlands East Management Authority organized a Stakeholders' Workshop on 13.01.2023 to address the challenges faced by the fishermen and farmers community of the East Kolkata Wetlands and to discuss the work plan of the IMP of EKW by engaging local community. The Workshop was

organized at the conference hall of Biswa Bangla Milan Mela Prangan, Kolkata. Sri Manas Ranjan Bhunia, Hon'ble Minister-in-Charge, Environment Department inaugurated the workshop by lighting lamp.

On the same day, the celebration of World Wetland Day, 2023 also began. EKWMA invited officials of the concerned departments, NGOs working on the EKW and representatives of local communities to participate in the workshop.

EKWMA also roped in all the key Government Departments on one platform in the workshop, with the aim to listen from the local community about the day-to-



day challenges being faced by them in fish and vegetable farming and their livelihood and to resolve these issues through involvement of concerned departments for sustainable management and conservation of East Kolkata Wetlands.

# 4.3. Showing pop-up message on Banglarbhumi Portal and Property Registration Portal

Due to the proximity to Kolkata, ordinary people have purchased land in EKW area with the intention of constructing building for residential and commercial purpose without the knowledge of it being a prohibited activity within the EKW area. To overcome this issue and enforce the prohibition on conversion of land use / change of character of land / construction of permanent nature within 37 Mouzas of East Kolkata Wetlands (EKW) area, it was decided in the thirtieth meeting of EKWMA that an online flag / pop-up message would be incorporated in the existing property Registration Portal and Banglarbhumi Portal. Accordingly, EKWMA has requested the Land and Land Reforms and Refugee Relief and Rehabilitation Department and Finance Department in this regard. An online pop-up message has been incorporated in Banglarbhumi Portal by L&LR Dept and in property Registration Portal by Finance Department for mouzas within EKW.

#### 4.4. Moving LED-Mounted Mobile Van

To attract public attention and educate general people, an audio-visual message on



importance of East Kolkata Wetlands was prepared. During this financial year, two LED mounted mobile vans displaying the above said audio-visual message travelled within EKW and its surrounding area from June, 2022 to August, 2022.

#### 4.5. Distribution of Leaflet and Miking

Fishing Cat (Baghrole) is the State Animal of West Bengal and EKW is a habitat of the Fishing Cat. It is an endangered species and the month of



February has been declared as Fishing Cat Month. This is an opportunity to take initiatives for protection of fishing cat along with the wetlands and its eco-system. In this regard, EKWMA distributed leaflet and carried out miking for protection of fishing cat as well as East Kolkata Wetlands in association with People United for Better Living In Calcutta (PUBLIC).

#### 4.6. Trips to East Kolkata Wetlands

4.6.1. Cycling Trip: On the World occasion of Environment Day a cycling was organized trip on 04.06.2022 in collaboration with Bengal Chamber of Commerce and Industry. The objective of the trip was to highlight the importance of wetlands being Ramsar site to an audience which was not much aware of its



intrinsic value. The trip was started from New Town Kolkata Development Authority (NKDA) and ended at Chaker bheri. Sixty persons participated in this trip.

4.6.2. Indian Audit and Accounts Department, Regional Training Institute, Kolkata: A field trip arranged was on 22.06.2022 for the Group-B officers of Indian Audit and Accounts Department. This trip was a part of Mid-Career Training Programme Environment Audit. on 20-25 officers Around participated in the field trip.





4.6.3. Centre for Urban Science and Engineering, IIT, Bombay: Ms. Swati Lokhende Ph.D. student of Centre for Urban Science and Engineering, IIT Bombay came to visit EKW understand the to mechanism of resource recovery practice from sewage-fed aqua-culture. Field staff of EKWMA took

her to visit EKW on 30.06.2022 and described the traditional pisciculture practice and sewage flow system within the EKW area.

4.6.4. Santoshpur Vidyamandir for Boys School: One field trip was organized for the students of Santoshpur Vidyamandir for Boys School on 09.03.2023 to gather knowledge about the waste management system of EKW and its Biodiversity. Forty two students along with their teachers attended this trip.

### West Bengal State Wetlands Authority (WBSWA)

West Bengal State Wetlands Authority (WBSWA) has been constituted under Rule 5(1) of the Wetlands (Conservation and Management) Rules, 2017 notified by the Ministry of Environment, Forest and Climate Change (MoEF&CC), Government of India. The WBSWA was first constituted in October, 2017.

### 6.1 Composition of the West Bengal State Wetlands Authority (WBSWA)

The WBSWA is a twenty members' body including five expert members in the field of wetland ecology, hydrology, fisheries, landscape planning and socio-economics. Five expert members have been re-nominated by the State Government for a period of three years in March, 2022. Member list is given at Table 4.

### 6.3 Staff strength of WBSWA

It was decided in the first meeting of WBSWA that the staffs of EKWMA will provide secretariat support to WBSWA. Accordingly, the staffs of EKWMA are also carrying out the work of the West Bengal State Wetlands Authority in addition to their normal duties.

### 6.4 Functions and Powers of the WBSWA

The State Wetlands Authority has following functions as per the Wetlands (C&M) Rules.

- To prepare a list of all wetlands of West Bengal.
- To prepare a comprehensive digital inventory of all wetlands and upload the same on a dedicated web portal to be developed by the Central Government.
- To prepare list of wetlands to be notified.

- To prepare brief documents of identified wetlands and recommend for regulation under the Wetlands (C&M) Rules, 2017.
- To develop a comprehensive list of activities to be regulated and permitted within the notified wetlands and its zone of influence.
- To ensure enhancement of the Wetlands (C&M) Rules, 2017.
- To generate awareness within the stakeholders and local community on values and functions of wetlands.
- To prepare an Integrated Management Plan of each notified wetlands for conservation and wise use of these wetlands considering traditional practices of those wetlands to maintain the ecological character of the wetland. Promotional activities of the stakeholders and local community are included in the Integrated Management Plan.

#### 6.5 Meetings of the WBSWA

During 2022-23, 3<sup>rd</sup> meeting of WBSWA was held on 03.06.2022 at the Chief Secretary's conference hall at 13<sup>th</sup> Floor, Nabanna. The meeting was chaired by Shri Hari Krishna Dwivedi, Chief Secretary, Government of West Bengal. Minutes of the meeting is attached in Annexure-IX.



# Major Activities of West Bengal State Wetlands Authority during the year 2022-23

#### **Back ground:**

After formation of the Wetlands (Conservation and Management) Rules, 2017, the West Bengal State Wetlands Authority has from time to time discussed regarding implementation of the Central Wetlands Rules.

The Hon'ble Supreme Court of India has provided direction on 08.02.2017 in the matter of *M.K. Balakrishnan & Others* to prepare brief documents of the wetlands with an area of more than 2.25ha identified in the National Wetlands Inventory & Assessment Project (NWIA).

On 24.11.2021 the Hon'ble High Court of Calcutta ordered the Chief Secretary, Government of West Bengal being the Vice-Chairman of the State Wetlands Authority to get all wetlands of the State identified.

The Hon'ble NGT, Principal Bench directed all the States on 25.11.2021 in the matter of *Raja Muzaffar Bhat Vs. State of Jammu and Kashmir &Ors.* to map all available wetlands apart from 2,01,503 wetlands identified *in M.K. Balakrishnan & Ors.* and prepare an exhaustive inventory for protection of wetlands, and also submit the same to National Wetland Authority.

Further, in the matter of *People United for Better Living in Calcutta (PUBLIC)* & *Anothers Vs. The Union of India & Others*, the Hon'ble National Green Tribunal, Eastern Zone Bench directed on 09.05.2022 that for protection of the wetlands, water bodies and flood plains in the entire State of West Bengal, consistent with the judgment of the Hon'ble Supreme Court in M.K. Balakrishnan & Ors. Vs. Union of India & Ors. A

Committee headed by the Chief Secretary, West Bengal was constituted by Hon'ble NGT to oversee compliance of the said Order.

For compliance of the above said direction, it was decided in the 3<sup>rd</sup> meeting of WBSWA held on 03.06.2022 that a Technical Committee would be constituted under the Chairmanship of Dr. Kalyan Rudra along with the representatives of Department of Fisheries, Land and Land Reforms and Refugee Relief and Rehabilitation, Water Resources Investigation and Development, Science and Technology and Bio-Technology, Panchayat and Rural Development, Public Health Engineering, Institute of Environmental Studies and Wetland Management to chalk out Action Plan for protection of water bodies / wetlands. Accordingly, a notification was issued vide no. 153-IESWM/4E-174/2022-23(525) dated 12.08.2022. A copy of the notification is attached in Annexure-X.

The Technical Committee has forwarded a pro-forma of Action Plan to all District Magistrates with a request to confirm the timeline to complete the work mentioned in the action plan to WBSWA and follow the work plan in time bound manner.

During this financial year, following activities had been undertaken:

### 1. Preparation of an inventory of the wetlands within West Bengal:

In the National Wetlands Atlas, 2010 prepared by the MoEF&CC, the total number of wetlands mapped in West Bengal is 1,47,826 including 1,38,707 wetlands smaller than 2.25 ha and 8911 wetlands bigger than 2.25 ha (excluding rivers). An inventory of 8,911 wetlands with an area of 2.25 ha and above has been prepared.

#### 2. Geo-tagging of the wetlands:

The work of geo-tagging of all the said 8,911 wetlands of the West Bengal with an area of 2.25 ha and above with Unique Identification Number has been started by Fisheries Department.

### **3.** Preparation of Brief documents:

- a) IESWM was engaged for preparation of brief documents of 23 wetlands with an area of more than 500 ha.
- b) Kalyani University has been assigned for preparation brief documents for 221 wetlands with an area of 10 ha or above.
- c) Preparation of brief documents of the rest of the wetlands has being given to the respective district administrations.

Minutes of the meeting of the East Kolkata Wetlands Management Authority held on 03.06.2022 in the Chief Secretary's Conference Room, Nabanna, Government of West Bengal

The list of participants is given in the Annexure.

Chief Secretary, West Bengal chaired the meeting.

- 1. Additional Chief Secretary, Environment Department briefed the members about the background, significance, Act and Rules relating to the East Kolkata Wetlands, different initiatives and actions taken by the East Kolkata Wetlands Management Authority (EKWMA).
- 2. East Kolkata Wetlands (EKW) located on the eastern fringes of Kolkata comprising an area of 12,500 hectares are the largest assemblage of sewage-fed fish ponds comprising around 250 water bodies across the districts of South and North 24 Parganas covering a total of 37 mouzas (30 full and 7 part) with a resident population of nearly 1,50,000 people. It is a mosaic of water bodies, agricultural land and homestead/settlements.
- 3. The shallow ponds of EKW, naturally recycle 910 Million Litres per Day (MLD) of sewage water generated from Kolkata city through phyto-remediation process. For this natural filtration process, the EKW deserves the description of being 'Kolkata's kidneys'. The natural wastewater purification system obviates the need for setting up of Sewage Treatment Plants (STPs) thus saving substantial capital and recurring expenditure. EKW produces 22 thousand tonnes of fish per year, 150 tonnes of vegetables per day and 16,0000 metric tonnes of paddy per annum. EKW is a part of Kolkata's lung system as a large amount of carbon sequestration takes place in the wetlands. EKW reduce the urban heat island effect. It soaks the excess rain water during monsoon and prevents the city from flooding. EKW also serves as the excellent ground water recharge system. EKW supports rich biodiversity and a total of 1925 species have been recorded.

4. In 2002, EKW was designated as a Ramsar site for being "wetlands of international importance". EKWMA is the nodal Government authority mandated to ensure wise use of the wetland within the regulatory framework defined by the East Kolkata Wetlands (Conservation and Management) Act, 2006.

### 5. Initiatives/ Actions taken by the EKWMA

- a) EKWMA has prepared a five-year Integrated Management Plan (IMP) as per the guidelines of National Plan for Conservation of Aquatic Ecosystems (NPCA). The total estimated budget of IMP is Rs 110.72 crores phased over a period of 5 years with the State's share of 40% and Central share of 60%. The IMP has been submitted to the Ministry of Environment, Forest and Climate Change (MoEF&CC) for release of fund. So far, after a rigorous and transparent screening process, nine organisations have been empanelled for implementation of different components of the IMP.
- b) In terms of enforcement actions, EKWMA has, till date, filed 358 FIRs against violations and also undertaken demolition of illegal structures from time to time.
- c) Environment Department has sanctioned Rs 1.98 crore to the Bidhannagar Municipal Corporation to undertake re-excavation of Bonghery Beel which had been unauthorisedly filled up to restore the original character of the land.
- d) For the first time, boundary demarcation on the ground has been undertaken to demarcate the EKW area physically by erecting pillars. 400 boundary pillars have already been erected at Mouza Garal, Samukpota, Nayabad, Kantipota, Ranabhutia, Atghara, Mukundapur, Jagatipota, Bhagawanpur, Karimpur, ChakKalar Khal, Nonaganga, Chowbaga of South 24 Parganas and DhapaManpur of North 24 Parganas.
- e) For the first time, afforestation drives have also been started in EKW area. The West Bengal Forest Development Corporation has completed the planting of 5269 saplings during 2021-22 covering the areas of Bamanghata, Kheadaha 1 and Tardaha Gram Panchayats at a total cost of Rs. 1.02 crore provided by the Environment Department, Government of West Bengal.
- f) For continuous awareness generation and public education on the need to protect EKW areas from encroachments and conversion, etc., two LED-mounted mobile vans have been deployed. To involve the general public, EKWMA has also conducted study tours and involved young volunteers as 'Wetland Mitras' for conducting awareness on related issues.

- g) During 2021, EKWMA along with the Zoological Survey of India (ZSI) has published the Biodiversity Profile of East Kolkata Wetlands. A per the latest surveys, a total of 1925 species (637 species of flora and 1288 species of fauna) have been recorded in EKW.
- h) EKWMA has coordinated with Water Resources Investigation & Development Department (WRIDD) and caused a survey of 17 canals (49.41 km) within EKW. Execution works of 2 canals, namely Bidyadhari-I and Tihuria have already been started by WRIDD.
- 6. Action taken by the Bidhannagar Municipal Corporation (BMC) for Solid Waste Management of MollarBheri: Dumping of household/ municipal waste at MollarBheri site has been completely stopped by BMC and New Town Kolkata Development Authority (NKDA). Boundary around the MollarBheri comprising an area of 15.86 acres has been completed with *ballah* pilling and drum sheet walling. Land reclamation through bio-mining has started on the site from February, 2021 with two trommels and is expected to be completed by March, 2023.
- 7. Action taken by the Kolkata Municipal Corporation (KMC) for Solid Waste Management at Dhapa dumpsite: At the State's oldest municipal waste dumpsite at Dhapa, a part has been successfully closed and capped by the Environment Department. The total estimated legacy waste accumulation in Dhapa dumpsite was approximately 40 lakh MT out of which 3.25 lakh MT of legacy waste has been mined and stabilized by spraying bio-culture. A compost plant with 500 TPD capacity, a plastic processing plant with 2 TPD capacity and 300 KLD capacity leachate treatment plants are in operation at Dhapa dumpsite.
- 8. After the presentation/ discussions on the points mentioned above, the directions of the Hon'ble NGT on East Kolkata Wetlands, issued from time to time, were discussed. These are:
  - *i.* To review the manner of disposal of sewage as well as the use of treated sewage for pisciculture, encroachments by concrete structures, and removal of illegal polluting units on Basanti Highway.
  - *ii.* Regular monitoring of water quality of wetlands and water bodies and stringent standards should be applied for any discharge in the water.
  - iii. Demarcation of boundary of East Kolkata Wetlands within stipulated time.
  - *iv.* A Monitoring Committee headed by the Chief Secretary, West Bengal may meet at least once a month and place its minutes on the website of the WBPCB.
- 9. After detailed deliberations, the following decisions were taken:

- a) Since large quantities of fish and vegetables are being produced in EKW for supply to Kolkata market, West Bengal Pollution Control Board (WBPCB) will regularly monitor the water quality of EKW's water bodies at different locations to ascertain if the level of sewage being discharged is optimal/ commensurate with EKW's natural filtration capacity. WBPCB shall submit this report to the Member Secretary, EKWMA on a monthly basis. The Institute of Environment Sciences and Wetland Management (IESWM) will also undertake similar studies on a regular basis for ascertaining the fish and horticultural produce from EKW is safe for human consumption.
- b) KMC and BMC shall review, monitor and remove encroachments within EKW regularly with the assistance of the police authorities. For removal of illegal polluting units on Basanti Highway, WBPCB will take similar action, with the assistance of the authorities concerned.
- c) It has been seen that in spite of the legal restriction on construction activity in EKW, some Gram Panchayats are issuing building permission for minor roads, culverts, buildings, etc in violation of the rules. It was decided that like in the past, the Panchayats and Rural Development Department will re-circulate an order prohibiting the panchayat bodies (concerned Zilla Parishads/ Panchayat Samitis/ Gram Panchayats of North and South 24 Parganas) from issuing approval (including online clearances, if any) for any construction activities within EKW, without prior clearance from EKWMA. The same advice shall apply to the KMC and BMC authorities in respect of the areas falling under them.
- d) Environment Department will pursue MoEF&CC for early release of funds for the implementation of the EKW Integrated Management Plan. In the meanwhile, funds available under the Environment Department's regular budget may be utilised. For maximum public participation in its implementation, the organisations selected by EKWMA through a transparent process may be utilised; efforts must also be made to involve self-help groups, wherever possible.
- e) To effectively enforce the prohibition on conversion of land use/ change of character of land/ construction of permanent nature within the 37 mouzas of EKW, an online flag/pop up message will be incorporated in the existing property <u>Registration Portal</u> by the Finance Department, and in the <u>Banglarbhumi portal</u> by the Land and Land Reforms and Refugee Relief and Rehabilitation Department (as has been done for lands of Tea Gardens and tribal lands). Such a facility will forewarn/ caution the buyers of land about lands falling under the notified boundaries of EKW and the restrictions on change of character of land/ conversion/ large-scale construction activities.

- f) The Water Resource Investigation and Development Department (WRIDD) will undertake the periodic de-siltation / re-excavation of the canals in EKW and surrounding areas, to ensure that the maintenance of the optimum level of water conducive to pisciculture and overall wetland management.
- g) EKWMA will publish advertisements in print and electronic media from time to time as well as on social media handles to make the public aware on the environmental importance of preserving EKW as well as the prohibition on land conversion and permanent construction within EKW. It will continue other measures for extensive awareness generation on the need to protect and conserve EKW.
- h) Since the concrete boundary pillars being erected by the district administrations of South and North 24 Parganas to demarcate EKW areas are small (not noticeable in the public eye) and of destructible nature, it was decided that high-mast steel signages of indestructible nature (as seen on National Highways) will be installed by Kolkata Metropolitan Development Authority (KMDA) beginning with the locations/ sites that are most vulnerable to encroachments; since this expenditure is towards environment protection, funding could be provided by WBPCB (from the proceeds collected/deposited as Environmental Compensation by different project proponents/agencies in terms of orders of NGT or any other related fund).
- i) A copy of these minutes shall be placed on the website of EKWMA and Department of Environment.

The meeting concluded with vote of thanks to and from the chair.

Roy Foundation, with an opportunity of hearing on 20.04.2022. The hearing was called with respect to the reconsideration of the application in Form 1 received by the office of the EKWMA on 28.12.2016 under Rule 8 of the East Kolkata Wetlands (Conservation and Management) Rules, 2006 from Sri Pradosh Kumar Janaray, Secretary, B.K. Roy Foundation with address at 91/1, Southern Avenue, Kolkata-700029. As per the East Kolkata Wetlands (Conservation and Management) Act, 2006 (hereinafter referred to as the "EKW Act of 2006") R.S. Dag No. 2 is classified as "Substantially water body oriented area (full)" and R.S. Dag No. 3 is classified as "Substantially water body oriented area (part)" and "Urban/ Rural settlement area (part)". As per the Record of Rights (Parcha) the land classification of both RS Dag nos. 2 and 3 is "Bastu".

#### CASE HISTORY:

Sri Pradosh Kumar Janaray, Secretary, B.K. Roy Foundation submitted an application in Form 1 which was received by the office of the EKWMA on 28.12.2016 under Rule 8 of the East Kolkata Wetlands (Conservation and Management) Rules, 2006. The applicant mentioned that the purpose of application is for promotion of education, healthcare, etc. by constructing a building. As per the East Kolkata Wetlands (Conservation and Management) Act, 2006 RS Dag no. 2 is classified as "Substantially water body oriented area(full)" and RS Dag no. 3 is classified as "Substantially water body oriented area (part)" and "Urban / Rural settlement area (part)". As per the Record of Rights (Parcha) the land classification of both RS Dag nos. 2 and 3 is "Bastu".

Due to the difference of land classification between the Land Reforms record (Record of Rights) and the Schedule of the EKW Act of 2006, a joint field inspection was conducted on 22.11.2017 at the subject land with representatives of the Office of the BL&LRO and the EKWMA. The subject land being a part of RS Dag nos. 2 and 3 was identified by the joint field inspection team. According to the joint field inspection report, water bodies existed on the portion of the subject land of the applicant-petitioners, while a portion of land was found lying vacant. In the said water bodies, pisciculture was going on at that time.

On 20.02.2018, the EKWMA informed Shri P.K. Janaray, Secretary, B.K. Roy Foundation, about the rejection of the application dated 28.12.2016 since the above subject land is within East Kolkata Wetlands governed by the Wetlands (Conservation and Management) Rules, 2017 (hereinafter referred to as the "Wetlands Rules of 2017") notified by the Government of India. According to the said Rules any construction of permanent nature is prohibited in wetlands.

On 04.07.2018, B.K. Roy Foundation filed a Writ Petition vide WP No. 11498 (W) of 2018 which was later on renumbered as WPA 11498 of 2018 in the Hon'ble High Court at Calcutta. On 15.03.2022 the Hon'ble High Court at Calcutta disposed of the matter with the following direction: "*The Chief Technical Officer being the respondent No. 2 is directed to reconsider the application filed by the petitioners in Form 1, which was received by the authority on December 28, 2016 afresh and dispose of the same by passing a reasoned order after giving an opportunity of hearing to the petitioners.*"

As per the Order dated 15.03.2022 of the Hon'ble High Court at Calcutta, on 20.04.2022 the Chief Technical Officer, EKWMA provided an opportunity of hearing to the applicant-petitioners B.K. Roy Foundation for reconsideration of the application dated 28.12.2016 in Form 1 on the subject land at part of R.S. Dag Nos. 2 and 3, Mouza-Kharki, J.L. No. 9, P.S. Sonarpur (presently under PS Narensrapur), Dist. South 24 Parganas.

#### **HEARING**:

The following persons attended the hearing on behalf of the applicant-petitioners:

- Shri P.K. Janaray, Secretary, B.K. Roy Foundation.
- Shri Samir Kumar Chakrabarti, Advocate.

During the hearing the Secretary, B.K. Roy Foundation said that they want to make building construction for education and healthcare purposes. And, the culvert has been made in front of their land as part of their rural development for the local people.

On 22.04.2022, Secretary, B.K. Roy Foundation made the following submission before the Chief Technical Officer, EKWMA:

- A letter dated 22.04.2022 along with copies of the following two plans approved by Pradhan, Kheadaha-II Gram Panchayat in 2014:
  - 1. Motorable bridge on canal (culvert),
  - 2. Boundary wall of the subject land.

#### CONCLUSION:

While considering the application dated 28.12.2016 submitted by B.K. Roy Foundation as well as examining the available records the following points were considered:

- According to Section 9 of the EKW Act of 2006, notwithstanding anything contained in any law for the time being in force, every person holding any land in the East Kolkata Wetlands shall maintain and preserve such land in a manner that its area is not diminished, or character is not changed except with the previous sanction of the Authority (EKWMA). So, the aforesaid two plans approved by Pradhan, Kheadaha II Gram Panchayat are not tenable and those are *void ab initio*.
- As per the published judgment of the Hon'ble Calcutta High Court in the matter of PUBLIC Vs. State of West Bengal & Others in 1992 the State Respondents were directed to maintain the nature and character of the wetlands in their present form.
- 3. On 09.12.2011, an order was passed by the then Chief Technical Officer, East Kolkata Wetlands Management Authority (EKWMA) stating that in accordance with the 17<sup>th</sup> meeting of the EKWMA held on 28.09.2011, the following resolution had been taken:

a. No new No Objection Certificate (NOC) for conversion of land shall be granted by the Authority.

b. All NOCs granted so far shall be revoked.

The applicant-petitioners applied before the EKWMA for change of character or change of mode of use of the subject land in the year 2016.

- 4. From the photographs annexed with the report of the joint field inspection conducted on 22.11.2017 it was found that water bodies existed at the land of the applicant-petitioners. This corroborates the land classifications mentioned in the Schedule I of the EKW Act of 2006.
- 5. East Kolkata Wetlands (EKW) being a Ramsar site came under the purview of the Wetlands (Conservation and Management) Rules, 2010 under the Environment (Protection) Act, 1986 notified by the Government of India from 04.12.2010. As per Rule 4(1)(vi) of the said Rules of 2010 any construction of a permanent nature was prohibited within the East Kolkata Wetlands.
- 6. In the year 2017, the Wetlands (Conservation and Management) Rules, 2010 were superseded by the Wetlands (Conservation and Management) Rules, 2017. Rule 4(2)(vi) of the Wetlands Rules of 2017 retained the same prohibition as mentioned in Rule 4(1)(vi) of the Wetlands Rules of 2010.
- 7. B.K. Roy Foundation has mentioned in their application in Form 1 that they want to make building construction at the subject land. But, as per Rule 4(2)(vi) of the Wetlands Rules of 2017 any construction of a permanent nature is prohibited within the East Kolkata Wetlands.

The Chief Technical Officer, East Kolkata Wetlands Management Authority has examined the matter and upon reconsidering all the above mentioned points including the imperative of environment protection, has decided not to grant NOC or sanction order under Section 10 of the EKW Act of 2006 to the applicant-petitioners, B.K. Roy

oundation. The applicant-petitioners are also directed to abide by the provisions of the East Kolkata Wetlands (Conservation and Management) Act, 2006 and the Wetlands (Conservation and Management) Rules, 2017.

All concerned may be informed accordingly.

### Reasoned Order

In compliance with the Order dated 22.08.2022 of the Hon'ble High Court at Calcutta in the matter of W.P. A. (P) No.393 of 2022 (Anrul Sardar Vs. The State of West Bengal & Others), the Chief Technical Officer, East Kolkata Wetlands Management Authority (EKWMA) provided the applicant-petitioners, Anrul Sardar with an opportunity of hearing on 27.09.2022. The hearing was called with respect to the consideration of the representation dated 08.08.2022 addressed to the Secretary, East Kolkata Wetlands Management Authority and Chief Technical Officer, East Kolkata Wetlands Management Authority alleging that one cricket ground situated at the middle of Boro Bon Gheri under Mouza- Dhapa Manpur, JL No.1 under P.S. Bidhannagar (South), District- North 24 Parganas situated within the East Kolkata Wetlands is being excavated by the EKWMA with the help of local authorities. In the said representation, the petitioner has stated that local people come for playing cricket in the said cricket ground and take fresh air, the local people are very much dependent on the field as there is no playground in the entire locality. The cricket ground provides oxygen to the entire locality. The petitioner has prayed before the EKWMA not to excavate the Bon Gheri and requested to take appropriate steps for proper maintenance of the cricket ground.

### CASE HISTORY:

i) The Hon'ble Division Bench of the Hon'ble High Court, Calcutta upon perusal of the supplementary affidavit filed in connection therewith in WPO No. 541 of 2017 came to a prima facie finding that *a two storied permanent building* construction has been taken place at Boro Bon Gheri , Choto Bon Gheri and Rabi Ghosher Gheri , under Mouza- Dhapa Manpur, JL No.1 under P.S. Bidhannagar (South), District North 24 Parganas within EKW which is a 'substantially water body oriented area'. The operative portion of the said order dated 29.11.2021 is reproduced herein below:

"....... Since we are of the prima facie view that the construction is on a land defined as a water body, we direct the appropriate authority to ensure that the building is not put to use and no electricity connection should be granted to the building and appropriate authority shall lock

and seal the building and file necessary documents of such action being taken duly supported by photographs along with the affidavit-in-opposition."

On 24.12.2021 the Hon'ble High Court at Calcutta was pleased to pass order in connection with the W.P.O 541 of 2017, wherein the Hon'ble Court directed the concerned authority under the EKW(C&M) Act, 2006 to take expeditious action in terms of Section 11 of the Act and give an opportunity of hearing to the person responsible for the illegal construction and complete the exercise in terms of the Section 11 of the Act as expeditiously as possible preferably within a period of four weeks. The relevant portion of the said order dated 24.12.2021 is reproduced herein below:

"Mainly two issues have been raised by learned counsel appearing for the petitioners. First is in respect of a double storied unauthorised construction which has been raised at Boro Bon Bheri, Chhoto Bon Bheri and Rabi Ghosher Bheri under P.S. Bidhannagar (South), District North 24 Parganas and .....

Hence, we direct the concerned authority under the Act to take expeditious action in terms of Section 11 of the Act and give an opportunity of hearing to the person responsible for the illegal construction and complete the exercise in terms of the said Section as expeditiously as possible preferably within a period of four weeks from today. Bidhannagar Municipal Corporation is directed to extend full help and cooperation to the concerned authority for the purpose of restoration of the land to its original position".

On 04.03.2022. W.P.O. 541 of 2017 came up for consideration before the Hon'ble Division Bench of this Hon'ble High Court, when the Hon'ble Court was apprised of the fact that opportunity of hearing was afforded to the petitioner and that pursuant thereto the order dated 08.02.2022 have come to be passed with a finding that the construction was unauthorized and direction to the petitioner, herein to dismantle the construction within 15 days. Relevant portion of the order dated 04.03.2022 is extracted herein below for ready reference:

"So far as the direction of this Court in respect of the illegal construction of double storied building on the wetlands as noted in the previous order is concerned, the affidavit reveals that the concerned person was given an opportunity of hearing in terms of Section 11 of the East Kolkata Wetlands (Conservation and Management) Act, 2006 and thereafter, the competent authority had passed the order dated 8th February, 2022 finding that the construction was unauthorized and directing the person responsible to dismantle the construction within 15 days, failing which the East Kolkata Wetlands Management Authority is to take necessary steps in terms of the provisions of the Act.

Learned Advocate General has informed that though the 15 days has lapsed but the person concerned has not removed the unauthorized construction. Therefore, interms of the earlier order now the unauthorized construction will be removed with the help of Bidhannagar Municipal Corporation.

ii)

This Court on 24th December, 2021 had already directed the Bidhannagar Municipal Corporation to extend full help and cooperation for the purpose of restoration of the land to its original position. Hence, we direct that the needful in pursuance to the decision of the competent authority dated  $8^{th}$ February, 2022 will be done within a period of three weeks and the compliance will be reported to this Court in the form of affidavit on the next date of hearing."

- *iv)* On receipt of the Order, District Magistrate, North 24 Parganas was directed to demolish the said two storied building and submit a report. District Magistrate, North 24 Parganas reported that the unauthorized and illegal structure has been duly removed/ dismantled on 23.03.2022 and 24.03.2022.
- v) On 18.04.2022 Member Secretary, EKWMA requested the Bidhannagar Municipal Corporation to restore the land to its original condition and provide a scheme and cost estimates for the restoration work.
- vi) On 29.04.2022, a revised cost estimate was submitted by Bidhannagar Municipal Corporation to the Member Secretary, EKWMA of Rs. 1,99,94,738 /- only for restoration of land to its original condition at Boro Bongheri, Choto Bongheri and Rabi Ghosher Bheri of Mouza-Dhapamanpur, JL No. 1 under PS-South Bidhannagar in Dist. North 24 Parganas, based on the 'Unified Scheme of Rates of Irrigation & Waterways Department''.
- *vii)* The said amount of Rs 1,99,94738/- has been released by the Environment Department for excavation of the land to its original condition at Boro Bongheri, Choto Bongheri and Rabi Ghosher Bheri, of which the cricket ground is a part of Boro Bongheri.

On 08.08.2022 Anrul Sardar filed a representation to the Secretary, East Kolkata Wetlands Management Authority and Chief Technical Officer, East Kolkata Wetlands Management Authority to stop excavating the Boro bongheri to save the cricket ground.


On 16.08.2022, Anrul Sardar filed a Writ Petition vide W.P.A,(P) No. 393 (W) of 2022 before the Hon'ble High Court at Calcutta. The Hon'ble High Court at Calcutta on 22.08.2022 disposed of the matter with the following direction: "Be that as it may, since the representation is already made by the petitioner, therefore, the concerned authority is expected to decide the said representation expeditiously".

In pursuance of the Order dated 22.08.2022 of the Hon'ble High Court at Calcutta, on 27.09.2022 the Chief Technical Officer, EKWMA provided an opportunity of hearing to the applicant-petitioners Anrul Sardar for hearing.

**HEARING:**

At the outset, the CTO, EKWMA briefed the petitioner and his advocate in detail about the orders of the Hon'ble Division Bench of High Court at Calcutta dated 29.11.2021, 24.12.2021 and 04.03.2022 in WPO 541 of 2017 in which the Division Bench of High Court at Calcutta has directed the EKWMA to take action as mandated by the provisions of the East Kolkata Wetlands (Conservation and Management) Act, 2006 and Orders of the Hon'ble High Court, Calcutta.

As per the East Kolkata Wetlands (Conservation and Management) Act, 2006 the entire Bon Gheri is classified as "Substantially water body oriented area".

According to Section 9 of the EKW (C&M) Act of 2006 notwithstanding anything contained in any law for the time being in force, every person holding any land in the East Kolkata Wetlands shall maintain and preserve such land in a manner that its area is not diminished, or character is not changed except with the previous sanction of the Authority

From 04.12.2010 East Kolkata Wetlands (EKW) being a Ramsar site came under the purview of the Wetlands (Conservation and Management) Rules, 2010 under the Environment (Protection) Act, 1986 notified by the Government of India. As per Rule 4(1)(vi) of the said Rules of 2010, any construction of a permanent nature was prohibited within the East Kolkata Wetlands.

In the year 2017, the Wetlands (Conservation and Management) Rules, 2010 were superseded by the Wetlands (Conservation and Management) Rules, 2017. Rule 4(2)(vi) of the Wetlands Rules of 2017 retained the same prohibition as mentioned in Rule 4(1)(vi) of the Wetlands Rules of 2010.

In the present case, the google imagery of 2018 shows that the area was waterbody. No permission was sought by the petitioner-applicant from EKWMA for change of character or nature of land. On the basis of the complaint of local Councillor on 01.03.2021, complaint was forwarded to South Bidhannagar Police Station to enquire into the matter and take action as per law. Police stated a case 69/21 dated 03.03.2021 and a field inspection was done by the team of CTO, EKWMA along with his team on 16.07.2021 wherein it was found that " *the waterbody have been filled up and a two storied permanent building has been constructed by violating the EKW Act and also the illegal activities are underway in full swing*". The Inspection Report was forwarded to the Commissioner of Police, Bidhannagar Police Commissionerate for taking action. On 17.09.2021 a stop notice was issued by the CTO, EKWMA.

Upon detailing the entire facts before the petitioner- applicant, the petitioner requested the CTO, EWKMA not to excavate the cricket ground as the same has larger public utility.

### CONCLUSION-

The Chief Technical Officer, East Kolkata Wetlands Management Authority has examined the matter and upon considering all the above mentioned points has decided to reject the representation of the applicant-petitioners, Anrul Sardar. The applicant-petitioners is directed to abide by the provisions of the East Kolkata Wetlands (Conservation and Management) Act, 2006 and the Wetlands (Conservation and Management) Rules, 2017 and to extend full co-operating to the State Government to abide by the Orders of the Hon'ble Division Bench of High Court ,Calcutta.

This has the approval of the Member Secretary, East Kolkata Wetlands Management Authority.

### Sub: W.P.A.(P). No. 385 of 2022 (Nirmal Basu-Vs- The State of West Bengal & Ors.)

Sir,

This is to bring to your notice that a Writ Petition W.P.A.(P). No. 385 of 2022 was filed in the Hon'ble High Court, Calcutta in which the petitioner has alleged that about 250 bighas of wetland at Chotto Paresher Bheri situated in Dhapa Manpur Mouza falling within East Kolkata Wetlands has been illegally converted from fishery to agricultural land in which paddy cultivation is taking place.

The Hon'ble High Court, Calcutta vide Order dated 22.08.2022 has disposed of the matter with a direction upon the East Kolkata Wetlands Management Authority to decide the representation of the petitioner expeditiously.

In compliance with the aforesaid Order, the East Kolkata Wetlands Management Authority provided an opportunity of hearing to the petitioner on 27.09.2022. The Petitioner was represented through his Advocate at the time of hearing and submitted a written statement stating that the character of Choto Paresher Bheri is converted from water body to agricultural land with a request to investigate into the matter.

On 19.10.2022 one Field Inspection was conducted by the staffs of EKWMA on the Choto Paresher Bheri, situated at RS Dag Nos. 1602 and 2255, Mouza-Dhapa Manpur, JL No. 1 under P.S. South Bidhannagar, District North 24 Parganas. The Field Inspection Report states that the "RS Dag Nos. 1602 and 2255 is fenced with concrete pillars and barbed wire, on which paddy cultivation is going on . Earlier, on this land there was a water body namely "Choto Paresh Bheri". As per ROR the land belongs to District Collector, North 24 Parganas. (Copy enclosed)

Section 9 of the East Kolkata Wetlands (Conservation and Management) Act, 2006 states that "Notwithstanding anything contained in any law for the time being in force, every person holding any land in the East Kolkata Wetlands shall maintain and preserve such land in a manner that its area is not diminished, or character is not changed or it is not converted for any purpose other than the purpose for which it was settled or previously held, except with the previous sanction of the Authority under Section 10."

Section 10(1) of the East Kolkata Wetlands (Conservation and Management) Act, 2006 states that "Any person holding a land in East Kolkata Wetlands may apply, in such manner as may be prescribed, to the Authority for change of character or mode of use of land."

The subject land is classified as "Substantially water body oriented area (full)" as per the schedule of East Kolkata Wetlands (Conservation and Management) Act, 2006.

You are requested to let this office know how the subject land has changed its character /mode of use of land (waterbody to agricultural land) without permission of the East Kolkata Wetlands Management Authority.

### **Reasoned Order**

The Hon'ble Division Bench of the High Court, Calcutta in the matter of W.P.A(P)No.360 of 2021 (Biplab Kumar Chowdhury Vs. The State of West Bengal & Ors.),vide Order dated 26.07.2022 has taken note of the fact that several unauthorized constructions have been raised at R.S. Dag No.1407 of Mouza- Dhapa Manpur, JL No.-56 (previously JL No.-01), P.S.-South Bidhannagar, District-North 24 Parganas. The Hon'ble High Court, Calcutta *interalia* directed the respondent authorities to take expeditious action for removal of the unauthorized constructions and file action taken report before the next date of hearing. In compliance with the aforesaid Order, the Chief Technical Officer, East Kolkata Wetlands Management Authority (EKWMA) provided the violators/occupiers with an opportunity of hearing on 07.11.2022.

### CASE HISTORY:

A case was filed by Biplab Kumar Chowdhury at the High Court, Calcutta alleging filling up of wetland and permanent constructions raised at RS Dag No.1407 of Mouza- Dhapa Manpur, JL No.56 (previously JL No.01), P.S.- South Bidhannagar, District-North 24 Parganas. A field inspection was done by the staffs of EKWMA on 04.03.2022 and found that several unauthorized constructions took place at Dag no.1407 of Mouza- Dhapa Manpur. Earlier, EKWMA forwarded a complaint letter on 22.11.2018 to the Inspector-in- charge, South Bidhananagar Police Station regarding illegal construction at RS Dag No.1407 and police started case vide No.182/2018 dated 25.1.2018 and charge sheet was submitted vide No.52/19. The Hon'ble Division Bench of the High Court, Calcutta vide Order dated 26.07.2022 *interalia* passed the following directions:

"....... Learned Counsel for the State is directed to get the demarcation done by the competent authority within a period of four weeks from today.

The respondent authorities are directed to take expeditious action for removal of the unauthorized constructions.

Let the action taken report be filed before the next date of hearing."

In compliance with the afore-said directions, demarcation of RS Dag No.1407 of Mouza-Dhapa Manpur, JL No.56 was conducted by the office of ADM&DL&LRO, North 24 Parganas, Barasat on 14.09.2022 in presence of the BL&LRO, Rajarhat, North 24 Parganas, authorized representative of EKWMA and authorized representative of Bidhannagar Municipal Corporation (BMC).

Thereafter, on 02.11.2022 hearing notice was issued by the EKWMA with the assistance of police authorities to the violators / occupiers who have made unauthorized constructions in RS Dag No.1407 to attend hearing before EKWMA on 07.11.2022 at 12.00 p.m.

The record of BL & LRO show that RS Dag No.1407 at J.L. No-56 is Government land belonging to Communication and Works Department. As there is no such Government office in the name of Communication and Works Department, Public Works Department (PWD) officials were asked to be present at the hearing. Representative of BMC was also requested to attend the hearing on 07.11.2022.

### **HEARING:**

At the outset, the Chief Technical Officer, EKWMA briefed the persons present about the Order of the Hon'ble Division Bench of High Court, Calcutta dated 26.07.2022, in which the Division Bench of High Court, Calcutta has directed the EKWMA to take expeditious action for removal of the unauthorized constructions as mandated by the provisions of the East Kolkata Wetlands (Conservation and Management) Act, 2006. As per the East Kolkata Wetlands (Conservation and Management) Act, 2006 the RS Dag No.1407 of Mouza- Manpur, JL No.56 plot is classified as "urban/rural settlement area".

According to Section 9 of the EKW (C&M) Act of 2006 notwithstanding anything contained in any law for the time being in force, every person holding any land in the East Kolkata Wetlands shall maintain and preserve such land in a manner that its area is not diminished, or character is not changed except with the previous sanction of the Authority.

Section 11(1) of the EKW (C&M) Act of 2006 states that if the authority is, either suo moto or on receipt of any information, satisfied that the character or mode of use of a land is being changed or has been changed in contravention of any provision of this Act, it may, by order in writing, require the person responsible for the change to restore the land at his own expense, to the original character or mode of use within such period as may be specified in the order and, in case of default by such person, undertake the restoration by itself and recover the cost thereof as arrears of land-revenue.

Provided that before passing the order the Authority shall give the person a reasonable opportunity of being heard.

From 04.12.2010 East Kolkata Wetlands (EKW) being a Ramsar site came under the purview of the Wetlands (Conservation and Management) Rules, 2010 under the Environment (Protection) Act, 1986 notified by the Government of India. As per Rule 4(1)(vi) of the said Rules of 2010, any construction of a permanent nature is prohibited within the East Kolkata Wetlands.

In the year 2017, the Wetlands (Conservation and Management) Rules, 2010 were superseded by the Wetlands (Conservation and Management) Rules, 2017. Rule 4(2)(vi) of the Wetlands Rules of 2017 retained the same prohibition as mentioned in Rule 4(1)(vi) of the Wetlands Rules of 2010.

In the present case, RS Dag No.1407 of Mouza- Dhapa Manpur, JL No.-56 (previously JL No.01), P.S.-South Bidhannagar, District-North 24 Parganas is Government land as per BL&LRO Record. The Councillor on behalf of the violators stated that the violators /occupiers are residing in the said plot generation-wise since independence. The said land in the disputed plot is not wetland but Sali land. The violators /occupiers are paying tax to the

Government. A few copies of tax receipts of Land & Land Reforms along with copies of Adhaar Card, voter card, ration card, electricity bill of some of the violators/occupiers were enclosed along with the written submission.

The violators/occupiers could not submit any documents regarding rights /title in the land. No documents were submitted by them seeking permission from any authority for construction of building at any point of time. No permission was sought by the violators / occupiers from EKWMA for change of character or mode of use of land.

The PWD official present in the hearing stated that he is not aware of the fact that the land belongs to PWD. The officials from BMC stated that in R.S. Dag No.1407 no permission was granted to the alleged violators/occupiers for any construction in the area.

### CONCLUSION-

Considering the above points, the Chief Technical Officer, EKWMA is of the opinion that violators /occupiers residing on R.S. Dag No.1407 have no title on the land. The constructions made on the R.S. Dag No.1407 is in violation of the provisions of the East Kolkata Wetlands Management (Conservation and Management) Act, 2006 and in violation of the provisions of the Wetlands (Conservation and Management) Rules, 2010. Hence, the violators / occupiers are directed to demolish the illegal construction on their own within 30 days of issuance of the Reasoned Order and the subject land be restored to its previous status, or else action shall be taken in accordance with law.

### **Reasoned Order**

It has come to the notice of East Kolkata Wetlands Management Authority (EKWMA) that construction of a bridge has been initiated over Bidyadhari 2 No. Khal, at bargheri area opposite bantala 2 no. bheri, RS Dag No. 1622/1796 & 1622/1797, Mouza: Dhapa, PS Anandapur, Kolkata Municipal Corporation Ward No.108 by blocking normal sewage flow of the canal. The aforementioned works are illegal and violate the provision(s) of section 9 of East Kolkata Wetlands (Conservation and Management) Act, 2006 and Rule 4 (2)(vi) Wetlands (Conservation & Management) Rules, 2017.

A complaint was lodged by EKWMA with the Anandapur Police Station on 09.12.2022. One case was initiated on the basis of the complaint by Anandapur Police Station vide Anandapur PS Case No.214 dated 14.12.2022 u/s 18 of the EKW (C&M) Act, 2006. It has been learnt that one Dukhiram Mondal@Dukhe is involved in the said construction. The Block Land & Land Reforms Officer, Kolkata, South 24 Parganas has reported that the recorded owner of both Plot No.1622/1796 (classified as KHAL) and the Plot No.1622/1797 (classified as BANDH) is Smt. Bandana Singh.

Adhering to the provisions of section 11 of the East Kolkata Wetlands (Conservation & Management) Act, 2006, the Chief Technical Officer, EKWMA vide letter dated 026/CTO/EN/108(7)/2020-2021(link-1) dated 27.01.2023 directed Smt. Bandana Singh, W/o Birendra Nath and Sri Dukhiram Mondal@Dukhe to attend the hearing on 09.02.2023 with relevant documents.

**HEARING:** 

On 09.02.2023 Sri Dukhiram Mondal@Dukhe attended the hearing but no one appeared on behalf of Smt. Bandana Singh .

### **Reasoned Order**

On 03.01.2023 a complaint was received from Sri Palan Naskar addressed to Chief Technical Officer, East Kolkata Wetlands Management Authority (EKWMA) alleging erection of a mobile tower by Sri Patiram Naskar at RS Dag No. 398, Khatian No. 523, Mouza-Hadia, J.L.No. 5, PS Kolkata Leather Complex, Dist. South 24 Parganas without permission from the EKWMA.

Meanwhile a writ petition has been filed bearing W.P.A. No.3175 of 2023 (Palan Naskar Vs. The State of West Bengal & Ors.) before the Hon'ble Division Bench of the High Court, Calcutta, regarding installation of the alleged mobile tower in village-Bamanghata, Naskar Para, Mouza-Hadiya, J.L.No. 398, under Bamanghata Gram Panchayat, P.S. Pragati Maidan falling within the EKW area as per the Schedule of the East Kolkata Wetlands Conservation and Management) Act, 2006 without permission of the EKWMA.

After enquiry into the matter by the staffs of EKWMA the name of the following persons have come up:

- 1. Sri Patiram Naskar, S/o Late Surendra Nath Naskar;
- 2. Sri Palash Sarkar, Tower Vision India, Astra Tower;

Hence, the violator, Sri Patiram Naskar is directed to remove the illegal telecom tower within 30 days of issuance of the Reasoned Order and to restore the subject land to its previous status, or else action shall be taken in accordance with law.

This issues with the approval of Member Secretary, EKWMA.

#### Government of West Bengal Department of Environment

Minutes of the meeting of the State Wetlands Authority held on 03.06.2022 in the Chief Secretary's Conference Room, Nabanna, Government of West Bengal

The list of attendees is annexed.

Chief Secretary, West Bengal chaired the meeting.

- ACS, Environment Department briefed the members about the Order of Hon'ble Supreme Court in M.K. Balakrishnan & Ors. v. Union of India &Ors passed on 08.02.2017 for protection of wetlands and the Order passed by the Hon'ble NGT, Principal Bench on 22.07.2021 in Raja Muzaffar Bhat Vs State of J&K & Ors. on identification of all wetlands in the State, which shall be included in the District Environment Plan.
- ACS, Environment Department also discussed the case related to filling up of wetlands in Mollarber and Panchghara Mouza in Dankuni, District- Hooghly. This case was transferred to the NGT, Eastern Bench by the High Court, Calcutta (W.P. No.26328 (W) of 2015 on 18.03.2016. Hon'ble NGT disposed of the matter on 09.05.2022 and passed directions, which were discussed at length.
- 3. ACS, Environment Department also highlighted the actions taken/ progress made on the subject in the recent months, as follows:
  - Water Resources Investigation Development Department (WRIDD) was designated as the Nodal Department for restoration of water bodies *vide* Notification dated 31.05.2021 in pursuance of the directions passed by NGT, Principal Bench, New Delhi on 18.11.2020 in O.A. 325/2015 in Lt. Col. Sarvadaman Singh Oberoi –Vs- UOI & Ors. Environment Department has requested WRIDD to coordinate with all District Magistrates (DMs) and inventorise significant wetlands as per the provisions of the Wetlands (Conservation & Management) Rules, 2017.
  - ii. Environment Department has provided to WRIDD KML files of 8,911 water bodies in West Bengal that are above 2.25 Ha.

- iii. As a first step, WRIDD has identified 2,437 water bodies that are more than 10 ha. and shared them with DMs to prepare their Brief Documents.
- iv. Till date, DMs have prepared a list of 246 wetlands having area 10 ha. and above and submitted factsheets for 153 wetlands. However, due to the technicalities involved, they could not prepare Brief Documents as per prescribed format of National Plan for Conservation of Aquatic Ecosystems (NPCA) Guidelines.
- v. The Institute of Environmental Studies and Wetland Management (IESWM) under the Environment Department has been entrusted to prepare Brief Documents of the identified wetlands. Considering the time-bound nature of this country-wide exercise and the very large number of water bodies that required to be mapped in the State, IESWM has found the scale and scope of the exercise beyond the capacity of its limited staff and has felt the need to outsource the preparation of Brief Documents to a professional agency or a University / Higher Education Institution.
- 4. After a detailed deliberation on all aspects of the matter, the following decisions were taken:
  - a) In the first phase of action, WRIDD as the nodal Department, will coordinate with the DMs and complete the geo-tagging exercise for waterbodies/ wetlands (assigning them unique number) as per NGT's instructions. Thereafter, demarcation of flood plains and catchment areas is to be done. This, and other exercises related to this work, will be done by WRIDD in association with the Fisheries Department, Science & Technology Department and Land Department since each of these Departments has large data bases/technical expertise related to the subject matter. Principal Secretary, WRIDD will coordinate efforts among these and other Departments/agencies, as may be necessary.
  - b) A Technical Committee will be constituted under the Chairmanship of Dr. Kalyan Rudra along with representatives of Fisheries Department, Land Department, WRIDD, Science & Technology Department, Panchayats and Rural Development Department, Public Health Engineering Department, IESWM, etc. to chalk out the State Action Plan for protection of water bodies/ wetlands within one month. WBPCB shall provide secretarial and other assistance for the same.
  - c) Preparation of Brief Documents of identified wetlands would be approached in two ways: the part relating to maps/ imagery/ land details, etc. of the water bodies shall be provided by the Fisheries Department / Science & Technology Department while the field study/ survey etc. would be entrusted to a State-

funded university, such that the entire exercise can be completed in a time-bound manner; funds for this exercise will be provided by WBPCB. Dr. Kalyan Rudra, Chairman, PCB and well-known River Expert agreed to coordinate this exercise.

- d) Chief Secretary reminded all the Departments that highest priority is to be accorded to the above-mentioned exercises as per the orders passed by Hon'ble NGT and stressed upon time-bound implementation.
- e) Minutes of this meeting will be uploaded on the website of SWA and Department of Environment.

# 5. Proposal for designating Rasik Beel, Coochbehar as Ramsar Site (Wetland of International Importance)

Considering the significance of the Rasik Beel wetland, as discussed in the previous SWA meeting held on 20.12.2019, the Chief Wildlife Warden (CWLW), West Bengal has proposed to SWA for designating it as a wetland of international importance. It is found that the site meets the criteria for designating it as a wetland of international importance (Ramsar site). It was agreed that keeping in mind the huge tourist potential of the Rasik Beel as well as its significant role in the local biodiversity, CWLW may prepare a detailed proposal as per NPCA Guidelines for onward transmission to Government of India for declaration of this water body as Ramsar site.

The meeting concluded with vote of thanks to and from the chair.
